JOINT ORDER 03/2021

SUBJECT: PhD Scholarship Programme of ULHT « 2021/2024 Triennium»

In compliance with the terms laid out in paragraph 3 of article 1 of the General Regulation of the Doctoral Scholarship programme of Universidade Lusófona de Humanidades e Tecnologias and for the three-year period 2021/2024, **it is decided:**

1. This programme covers the Doctoral programmes in:

* The number of scholarships to be awarded in the Doctoral Programmes in association will be 4 (four) for each Institution, resulting from the equal division of the scholarships authorized by the instituting entity.

2. For the verification of the requirements for maintaining the scholarship annually, **until 31 January the course directors shall send to the rectory the nominal list of scholarship holders, indicating that the requirements imposed have been met**, for joint homologation by the Rector and the Administrator, and forwarding to the services for due purposes.

3. The scholarship holders shall enrol for the following academic year after being informed of the grades.

4. Specific conditions of financial responsibilities during the three-year period:

4.1. The scholarship holders are **exempt** from the payment of:

- 4.1.1. Tuition Fee;
- 4.1.2. Thesis Submission Fee;

4.2. The scholarship holders are obliged to pay:

- 4.2.1. Application Fee;
- 4.2.2. School insurance, annually;
- 4.2.3. Registration/enrolment in the first year;
- 4.2.4 Certificates/Statements and Doctoral Charters.

4.3. The Scholarship does not cover any other expense.

5. Scholarship holders may request an extension of the Scholarship benefit period for:

- 5.1. a supplementary period, provided it does not exceed twice the prescribed duration of 3rd cycles (12 semesters) and under the provisions laid out in paragraph 3 of Article 2 of the General Regulation;
- 5.2. the extensions authorized by the Programme Director, with due justification, are sent to be homologated by the Rector for further forwarding to the competent services;
- 5.3. failure to comply with item 5.1 will result in the loss of the scholarship and should the student wish to continue, he/she must make the payments to continue and complete the degree, in accordance with the charges and fees defined.

6. The Doctoral Scholarship Program of ULHT shall be governed by the General Regulation approved by Joint Order 02/2019 of 10 January, in force.
